

## **Before and After School Program**

## Tuition Due Dates: 2024-2025 School-Year

## Why is the same monthly tuition due for all months, including extended break months? The monthly tuition rate is established based on the total number of days on the school calendar, using before and

after school program hours, and is distributed over all of the school months (some months have more days, some months have less days). The full monthly tuition is due each month.
